These terms and conditions (**Terms**) apply to your use of this Website (**Website**), being the web pages located at [www.memobooks.com.au](http://www.memobooks.com.au) and all components of and content on those pages. If you access or use the Website, you are taken to accept these Terms.

We may change these Terms at any time without notice. Any changes will apply from the time they are included on the Website and will bind you if you use this Website after this time.

This Website is owned and operated by **Little Village Books Pty Ltd** (ACN 624 424 031) trading as **me mo books** (ABN 416 624 424 031) (**me mo books**). References to “we” or “us” are to me mo books and references to “you” mean you, the Website user. Downloadable drawing books by **Squiggle Kids**, a business name registered to Little Village Books Pty Ltd, are also sold on this Website.

1. **Other website terms:** When you access or use the Website you may access or use other websites with content and functionality that we are not responsible for and that are subject to different terms of use. The terms of these other websites apply when you access or use these other websites and not these Terms.
2. **Prices:** All prices are in:
  - Australian dollars and inclusive of GST if the AUD option on the Website is selected; and
  - New Zealand dollars if the NZD option on the Website is selected.

Our online prices may change without notice and may vary from the prices for me mo books or Squiggle Kids product(s) sold elsewhere.

3. **Products:** The actual colours of our products you see online will depend on the resolution, display settings and capabilities of the screen you view them on.

4. **Product Availability:** We sell both physical books and downloadable drawing books. Please check the availability of the physical product you wish to purchase on our Website. Once we have received your order, you will receive an email confirming receipt of your order. This is not a guarantee of availability for a physical product. Supply issues or unexpected demand may occasionally result in physical product stock being temporarily unavailable.
5. **Payment:** We accept payment via:
  - the Square AU Pty Ltd (ABN 38 167 106 176) system (for the AUD option on the Website only). Please see Square's website for their Square Seller Agreement and Privacy Policy (available at <https://squareup.com/au/legal>)
  - the Paypal Australia Pty Limited (ABN 93 111 195 389) system (for both AUD and NZD options on the Website). Please see PayPal's website for their User Agreement for Paypal Services (available at <https://www.paypal.com/au/webapps/mpp/ua/legalhub-full>)
6. **Time for shipping:** Your physical product(s) will be shipped once payment has been received by us. Your downloadable products will be delivered to your email address once payment has been received by us.
7. **Delivery Address:** Please specify an accurate:
  - email address for downloadable products as there may be delays where an incorrect email address has been nominated; and
  - delivery address for your physical product order as we are unable to redirect parcels once dispatched. Where the shipping address differs from the billing address, please ensure permission is obtained from the occupant of the specified delivery address.
8. **Dispatch timeframes:** Orders of physical products placed with all products in stock will be dispatched within 2 to 4 business days. Orders of physical products out of stock will be dispatched within 2 to 4 business days of the product(s) becoming available.
9. **Shipping:** We offer the following shipping / collection options for physical products:

- **Ship within Australia** This is via the Australia Post letters service, which does not offer tracking;
- **Collect for FREE – Surrey Hills, Melbourne:** Pick up is available from a location in Surrey Hills in the eastern suburbs of Melbourne; and
- **Ship to New Zealand:** This is via the Australia Post international letters service, which does not offer tracking.
